



## Credit Card Usage Survey

5/1/2021 - OFFICIAL CONTEST RULES

**ELIGIBILITY:** The credit card usage survey is open to legal United States residents eighteen years of age or older, that received the prescreened mailer and email. Keesler Federal employees, officials and immediate family are not eligible to participate. Contest is offered to Keesler Federal credit card holders that participate in the usage survey and meet the following criteria: Void where prohibited. **DURATION:** Contest begins at 12:01 a.m. Central on 5/15/21 and ends 11:00 p.m. Central 6/30/21. Keesler Federal reserves the right to modify or end the promotion at discretion.

**HOW TO ENTER:** To enter, complete the online survey listed in the email or postcard. By submitting an entry, entrant gives Keesler Federal permission to make contact by email or phone.

**PRIZES:** 3 -\$100 Visa credit card statement credits. Winners may only win one prize. Keesler Federal may substitute a prize offered at its discretion.
