OFFICIAL CONTEST RULES ("Rules") | 3.3.23

**ELIGIBILITY:** The Keesler Federal Credit Union 5 Days of Prizes drawings are open to Keesler Federal members with accounts in good standing, opened prior to 3/20/23.

Contest is offered to 381 randomly selected primary members. Employees and officials are not eligible. Void where prohibited. All federal, state, and local laws and regulations apply. Contestant must be a Keesler Federal primary account holder in good standing to be eligible.

**DURATION:** Contest begins March 20, 2023 and ends March 24, 2023.

**HOW TO ENTER:** No entry is necessary. All primary members in good standing are automatically entered. Members do not have to be present at the meeting or in-branch to win.

**PRIZES:** (Members do not be present at the annual meeting to win)

- Each day, March 20-24, 2023, 75 members will win a \$75 deposit. One member will win a \$1,000 deposit. Winners may only win one prize within the week. Funds will be deposited to winner's primary share account within three business days.
- On March 23, 2023, one primary member in good standing, age 18 or over will win a new vehicle valued at approximately \$32,000. The prize will include tax and title. Member has the option to sell the vehicle back to selected dealership at average NADA retail value. Vehicle will be delivered or shipped within the continental US. Should winner reside overseas, a cash equivalent will be offered.

**SELECTION OF WINNERS:** Winners will be determined by a random drawing from all eligible members to be held each day: March 20, March 21, March 22, March 23, March 24, 2023. All decisions are final and binding. Odds of winning will be determined by the number of eligible members. Winners will be notified by phone call and/or email the day of the win.
