**OFFICIAL CONTEST RULES**

**ELIGIBILITY:** The Keesler Federal Credit Union Teller Satisfaction Survey Drawings are open to legal United States residents eighteen years of age or older. The contest is offered monthly to survey participants, and three winners will be randomly selected. Contestant must be a Keesler Federal primary account holder in good standing to be eligible. Employees, officials, and immediate family are not eligible to participate in the contest. Void where prohibited. All federal, state, and local laws and regulations apply.

**DURATION:** The Teller Satisfaction Survey drawings will begin in March 2023 and continue every month after that until the credit union discontinues this program.

**HOW TO ENTER:** To enter, members must complete and submit the survey. Three winners will be selected each month. Each winner will receive \$100. The funds will be deposited into the winner's primary share account within 30 days of selection. No purchase is necessary to enter or win.

**SELECTION OF WINNERS:** Winners will be determined by a random drawing from all eligible entries to be held the first day of every month. All decisions are final and binding. Odds of winning will be determined by the number of eligible entries. Winners will be notified by e-mail or phone within the first 10 days of every month.

**CONDITIONS:** By entering and/or accepting prizes, entrants, participants, and winners agree to be bound by these rules and the decisions of Keesler Federal Credit Union which shall be final. Participants agree that Keesler Federal is not responsible for and shall not be liable for (1) telephone, electronic, hardware or software program, network, Internet, or computer malfunctions, failures, or difficulties of any kind; (2) failed, incomplete, garbled, or delayed computer transmissions; (3) any condition caused by events beyond the control of the sponsor that may cause the contest to be disrupted or corrupted; (4) any injuries, losses, or damages of any kind arising in connection with or as a result of the prize, or acceptance, possession, or use of the prize, or from participation in the contest; or (5) any printing or typographical errors in any materials associated with the contest.
