

OFFICIAL TICKET TUESDAY CONTEST RULES

Contest Dates: 10/29/2024 – 10/31/2024

ELIGIBILITY: 5 sets of (4) New Orleans Pelicans tickets and 1 set of (4) New Orleans Saints tickets giveaway is open to legal United States residents eighteen or older.
