

OFFICIAL TICKET TUESDAY CONTEST RULES

Contest Dates: 12/30/2024 – 1/2/2025

ELIGIBILITY: 1 set of (4) Pelicans tickets giveaway is open to legal United States residents eighteen or older. Keesler Federal employees, officials, and immediate family are not eligible to participate. Void where prohibited. All federal, state, and local laws and regulations apply.
