

OFFICIAL TICKET TUESDAY CONTEST RULES

Contest Dates: 8/27/2024 – 8/29/2024

ELIGIBILITY: (2) Saints tickets and (1) parking pass giveaway is open to legal United States residents eighteen or older. Keesler Federal employees, officials, and immediate family are not eligible to participate. Void where prohibited. All federal, state, and local laws and regulations apply.

DURATION: The contest begins at 12:01 a.m. CST on 8/27/24 and ends at 11:59 p.m. CST on 8/29/24. Keesler Federal reserves the right to modify or end the promotion at discretion.

HOW TO ENTER: Participants enter by following the Keesler Federal Facebook or Instagram page, commenting, and tagging a friend. No purchase is required. Include your name, address, phone number, and email on the index card.

PRIZE: (2) Saints tickets and (1) parking pass.
